Code on Conduct

The function of this committee is to ensure that all games are played under the umbrella of good sportsmanship, exhibiting a code of discipline. Listed below is a guideline as to penalties should a team or player(s) misbehave.

The penalties stipulated above is only a guideline, and depending on the severity of any incident(s) mentioned above, the Disciplinary Committee has the authority to consider instituting further penalties, or increasing the present penalties.

All fines must be paid before or on the date stipulated by the Disciplinary Committee. Failure to do so shall result in forfeiture of the game.

Suspension will apply only to the qualifying and play-off games of the Round Robin Competitions of that year and if necessary the following year.

Any player(s) fined, and refused to pay will not play until that fine is paid. If the player(s) departed from S.S.B.C.A and return the following year, that fine will still be outstanding and MUST be paid before the player(s) can play. There is no limitation as to the time where payment of the fine is concerned. All suspensions, bans, and fines will be posted on the Internet.

The management committee has the right to revoke the status of any member of the disciplinary committee if found not performing there duties. ALL INFORMATION AND DISCUSSION HELD BY THE DISCIPLINARY COMMITTEE MUST BE KEPT CONFIDENTIAL AT ALL TIMES. ONLY THE MANAGEMENT COMMITTEE HAS THE RIGHT TO REVIEW ALL INFORMATION AND DISCUSSION FROM THE DISCIPLINARY COMMITTEE
